1. Complying with A.W. 112, a Summary Court-Martial, convened at Kansas City, Mo., pursuant to S.O., 228, Hq., KCQM Depot, dated 25 September 1943, for the purpose of disposing of the effects of the above-named soldier, or person subject to military law, reports that:

a. No legal representative or widow of decedent being present at decedents camp or quarters, effects of decedent were forwarded to this Summary Court-Martial.

b. Local debtors owed decedent's estate \$ none, of which the sum of \$ none was collected. (If nothing was found due or collected, state "None"; otherwise attach itemized statement of sums owing and collected.) (Incl. _____.)



This is to inquire concerning Pfc. Joseph N. Quail 32702351 of 3246 Kingsbridge Avenue, New York 63, New York whose last address was Company K, 331 Infantry, A.P.O. 83, c/o P.M. New York.

The War Department notified his mother that he was killed in action on July 1, 1944, somewhere in France. Although we have never had any replies from our letters to the Chaplain and others in authority, his mother did receive a package of some personal effects. No word has come regarding his death, however - where it occurred, in what manner, or what disposal was made of his remains.

Joseph's brother, Peter David, was killed in action in New Guinea on August 6, 1944. We have heard definitely from his Chaplain. Our youngest, Richard, is now Pfc. at Fort McClellan in Alabama.

You can perhaps realize the agony and strain felt by the family. Details regarding Joseph would be very much appreciated. May we hope to have some word from you?
