SUBJECT: Supplemental Missing Air Crew Report.

TO : Commanding General, Ninth Air Force, APO 696, (ATTN: 26th Statistical Control Unit).

1. Reference Missing Air Crew Report, submitted by this Organization, dated 9 June 1944; and Supplemental Missing Air Crew Report dated 20 June 1944. The following changes have been made on the casualty status as shown below, for Aircraft No. C-47, 41-38679:

BARRACO, ANDREW J. Cpl 32560061 from "MIA" to "KIA". ✓ 569

ELISRAND, HOWARD E. S/Sgt 39019097 from "MIA" to "KIA". ✓

RISLEY JR, GEORGE 2d Lt 0525178 from "MIA" to "KIA". ✓ 10.96

STURGES, SYLVESTER H. 2d Lt 0750479 from "MIA" to "KIA". KIA

2. Approximately 1700, 7 June 1944, as was stated by an eye witness, aircraft No. C-47, 41-38679 was found about one (1) mile northeast of a little village called Sebeville, France. The plane was badly demolished, and with the exception of the tail assembly, was burned. The tail assembly had been completely severed from the rest of the plane, but it was possible to identify the above numbered plane. It did not appear possible that anyone could have recovered. Trunks of three bodies were found, with parts of a body in or about the area of the plane where the Navigator and Radio Operator are stationed. There were two bodies found in the Pilot and Co-Pilot positions, and another body found near the back of the plane, (reference of bodies used herein implies the trunks of bodies). There were no other wrecked planes within that area which would have been confusing to the witness, and no combat action in the proximity of the wrecked aircraft. One dog tag, property of Cpl Andrew J. Barraco, was located near the trunk of the body at the back of the plane.

3. The information contained in paragraph 2 of this letter was obtained from Flt O. JACK C. TURNER, who together with Flt O. LUNDAY, members of the 73d T.C. Sq, were engaged in gathering supplies dropped by parachute.
